MiSecure MDR Solution

In the 2023-24 School Aid Fund, section 97g allocated \$9,000,000 to provide a statewide Security Operations Center (SOC) and Managed Detection and Response (MDR) services to ISDs, local districts and PSAs in the State of Michigan. Funding was secured through Ingham ISD which worked with the Michigan Association of Intermediate School Administrators (MAISA) to establish this SOC. The Michigan Education Technology Leaders (METL) had previously formed the MiSecure Cybersecurity Task Force and this team was utilized to form the new MiSecure Operations Team.

The MiSecure Operations Team is dedicated to providing advocacy and leadership around cybersecurity tools and practices for all Michigan schools. As directed in the 97g language, MiSecure has now selected and is making available MDR software for all critical servers in every ISD, local district and PSA. In order to participate, ISDs must fill out this survey.

This survey should be filled out only one time by each ISD. If, after filling out the survey, you have changes or updates, you need to reach out to <u>misecure@gomaisa.org</u> before submitting a second survey.

Before filling out the survey, make sure you understand the program requirements. Questions are being answered and maintained in our FAQ, available on the <u>http://www.misecure.org/</u> website. In particular, understand that licenses are only available to "critical technology infrastructure" which the MiSecure team understands to mean "servers."

Make sure you have the total number of <u>new MDR licenses</u>, the total number of <u>credit requests</u> (and for which products), and the total number of <u>upgrades from Crowdstrike EDR</u> (if any). These numbers need to include all local districts and PSAs. Exceptions can be noted in the survey.

Understand that each ISD will receive a unique Customer ID (CID) to manage the cybersecurity for all servers in the ISD, local districts and PSAs. A local district or PSA may elect to participate on their own, but will need to work with MiSecure to purchase their own CID.
